DEED OF ACKNOWLEDGMENT, RELEASE & INDEMNITY

I consent to the Participant contesting and taking part in the Challenge under the terms and conditions of this Deed of Acknowledgement, Release & Indemnity ("Deed") and agree that the Participant shall be subjected to the terms and conditions of this Deed and the attached Rules & Regulations. I warrant that the Participant accepts and will comply with and obey fully the attached Rules & Regulations.
2. The Participant and I fully understand and acknowledge that THE CHALLENGE IS POTENTIALLY DANGEROUS and, in consenting to the Participant taking part in the Challenge, I acknowledge that I and the Participant ACCEPT ALL RISKS ASSOCIATED WITH THE CHALLENGE and that such acknowledgement is a condition precedent prior to the Participant taking part in any capacity in the Challenge.
3. I warrant that the Participant has not at any time suffered any blackout, seizure, convulsion, fainting or dizzy spell, back, leg, arm or neck injury, or heart complaint and is not presently receiving treatment for any illness, disorder or injury which may render it unsafe for the Participant to take part in the Challenge.
4. I warrant that the Participant has undergone a medical examination by a qualified medical practitioner who has certified that the Participant is fit to take part in the Challenge.
5. I for myself and for the Participant and the Participant's executors, administrators and other personal representatives acknowledge that MediaCorp, its related/affiliated companies, and their respective officers, employees, servants and agents will not be responsible or liable for, and release and forever discharge MediaCorp, its related/affiliated companies and their respective officers, employees, servants, agents and all persons



authorized by it or them or any of them from, any claim, liability, damages, cost, loss or expense whatsoever in respect of:

- Any injury or health problems to the Participant (including nervous shock) and including any injury or health problems resulting in mental or physical illness whether temporary or permanent and injury or health problems resulting in death;
- Loss of earnings or earning capacity;
- Any impairment of enjoyment of life;
- Loss of or damage to the Participant's property and personal belongings;
- Pain and suffering by the Participant;
- The Participant's death; and/or
- Any loss of any other kind whatsoever

arising out of the Participant taking part in the Challenge or arising from compliance with the attached Rules and Regulations and I agree that this Deed may be pleaded to any such claim.

6. The releases contained in Clause 5 shall operate in respect of any loss or damage sustained or suffered by the Participant however caused, including loss or damage suffered due to the negligence, omission, lack of reasonable foresight, lack of reasonable care or failure to take adequate precaution by MediaCorp, its related/affiliated companies and their respective officers, employees, servants and/or agents.
7. I warrant and acknowledge that the Participant and I have not relied upon any expertise, representation, warranty or statement whatsoever of MediaCorp, its related/affiliated companies and/or their respective officers, employees, servants or agents in choosing to participate in the Challenge and I further acknowledge that MediaCorp has advised that neither it, nor its related/affiliated companies, their respective officers, employees, servants or agents have any experience or expertise whatsoever in relation to the activities involved in the Challenge. 11. This Deed shall be governed by and construed in accordance with Singapore law.
12. If this Deed is translated into any other languages, such other language versions are for reference only and shall not be used in the interpretation of this Deed. The English version shall prevail in all circumstances.
